As a Senior Evaluator, you will be contracted on either a short-term or long-term consultancy basis to design and implement innovative, rigorous peacebuilding evaluations. You will work independently or lead one or more evaluation teams. You will possess sound design skills and experience, preferably with mixed methods, and be familiar with peacebuilding, fragility and conflict programming. You will have excellent leadership, presentation, and client engagement skills.

Terms of Reference

Your main responsibilities will likely include:

- Leading or advising on the design and/or implementation of evaluations for PEARL, including but not limited to designing evaluation approaches, data collection and sampling strategies, dissemination approaches, and project plans.
- Working closely with the PEARL Task Order (TO) Manager, Senior Learning and Outreach (L&O) Specialist, PEARL Project Management Unit, and PEARL consortium partners to incorporate relevant input into the design, and delivery of PEARL evaluations.
- Providing input on teaming, consortium building, work planning and budgets to the PEARL (TO) Manager and Project Management Unit as needed.
- Providing overall technical direction, quality assurance, and management of evaluation teams to ensure Integrity delivers on time and to high quality standards.
- Acting as trusted advisor to USAID/CVP Evaluation Activity Managers, and build strong relationships with key stakeholders on evaluation design, delivery, and uptake.
- Providing regular, timely updates on progress to the TO Manager.
- Convening internal Collaboration, Learning and Adapting sessions at key junctures to capture learning on PEARL evaluation approaches, and activities in close coordination with the PEARL Senior L&O Specialist.
