Scope of Work

You will support the US Team in identifying and pursuing new project opportunities, maintaining account management systems and records. Also, assist in managing Integrity's consultant network, support logistical, compliance and contractual processes, and the production of marketing and communications materials. You will primarily report to a Business Manager but will work with the wider global Business Team. The position is Washington, DC, based with international travel as required.



Terms of Reference

The Business Officer role requires a proactive and energetic individual with strong research, writing, negotiation and people skills. The right individual combines the drive to compete for and win large-scale contracts with the emotional intelligence required to work across different teams, geographies and cultures.

A. Business Development (65%)

- Support the delivery of Integrity's Business Development (BD) strategy by working as a core
 member of the Business Team and coordinating closely with team members in our international
 offices and with Integrity's Services, Operations, and Finance Teams.
- Help grow and manage a BD pipeline of USAID and other international development donor projects, in line with geographical, thematic, and technical strategies. This enables us to deliver company-wide financial targets on a quarterly basis.
- Identify, scope and upload opportunities, aligned to Integrity's core areas of focus on to our internal knowledge management systems.
- Support identification and management of new accounts, ensuring relevant information is captured accurately on internal databases.
- Support company-wide prepositioning for business opportunities, including competitor mapping, consortium selection and engagement, brand and messaging. Also, teaming and staffing, development of track record documents, financials and compliance documentation. There may be opportunities to specialize in certain regions or thematic areas.
- Support bid managers on specific proposals, including helping with the development of proposal calendars, technical outlines and compliance matrices. Also, careful notetaking on milestone meetings, associated logistics for partnership and teaming arrangements, final compilation, formatting and polishing of proposal submission volumes.
- Support the development of the technical, including writing discrete sections and cost proposals.

B. Bid Recruitment and Bid Consultant Management (10%)

- Help identify and recruit team members for key bid and proposal processes, including but not limited supporting the definition of roles and level of effort.
- Prepare tailored CVs and write-ups for proposed personnel on bids.
- Quality assure the registration of new personnel on Integrity's knowledge management systems.
- Help identify new consultants for Integrity's bid surge support bench, support personnel and consultant management systems, processes and strategy as needed.

C. Marketing and Communication (10%)

- Support the production of corporate marketing materials, including news items for the Integrity website and social media channels.
- Compile and update relevant capability and past performance statements for use in BD and corporate marketing materials.
- Assist in formatting, copy-editing, and publishing/disseminating job advertisements.



D. Other (15%)

- Provide administrative support to Integrity's awarded IDIQ contracts, including tracking and uploading task order opportunities into the system.
- Other research tasks for proposals or projects.

Your Experience and Expertise

The ideal candidate will have:

- Relevant academic or professional qualification, academic background, Bachelors or Masters in International Relations, Economics, Political Science or related field of study.
- At least 1-2 years of work and/or internship experience, with demonstrated interest in the field of international development or related subject areas.
- The desire to work on the business side of the company building relationships and networks.
- The drive to continuously develop from proposal to proposal.
- Demonstrated ability to produce high quality written products, including narrative and persuasive writings and social media postings.
- Curiosity and a keen interest in the subject matter of Integrity's work.
- Excellent time management and attention to detail.
- A team player approach with a positive attitude, willingness to both learn from others and lead others.
