This includes support for effective planning, robust design, performance reporting, conducting special studies, DQA, ME&L, CLA, and KM at all levels to support programs. And activities from Peru's bilateral and South America Regional portfolios, as well as from USAID Missions in South America. Overall, the ultimate expected results of this Contract are to strengthen USAID's program cycle systems in the bilateral and SAR programs, and to enhance the capacity of local/regional entities in order to improve the use of evidence for programming, learning, and adaptive management.

Scope of Work

Integrity is looking for a dynamic Chief of Party (COP) for USAID/Peru's Program Cycle and Monitoring, Evaluation, Collaboration, and Learning Support activity. The multi-year activity will provide a range of monitoring, evaluation, learning, and adaptive management services to USAID/Peru's bilateral and South America Regional portfolios, as well as USAID Missions in South America. The COP will lead the technical direction and manage overall operations of the activity tasks while ensuring the performance is delivered in accordance with quality standards, schedules, and approved costs. S/he will serve as the main point of contact for the client and external stakeholders. Please be advised that the position is dependent on contract award.

Terms of Reference

- Provide overall strategic leadership and day-to-day management of the activity.
- Serve as the primary point of contact to USAID on day-to-day activity implementation, management, and reporting issues.
- Develop collaborative relationships with key stakeholders, including the USAID/Peru Mission and relevant regional, and national actors including implementing partners, government institutions, and other professional organizations.
- Lead and manage the activity team to achieve activity results and ensure coordination across components, as well as among technical, activity management, and finance and administrative teams.
- Lead the development of annual and quarterly workplans, and progress reports per client contractual requirements.
- Oversee and ensure quality assurance of all monitoring, evaluation, learning, reporting, and dissemination activities under the contract.
- Mentor, support, and supervise activity staff and directly manage consultants, ensuring technical capacity and providing technical assistance and backstopping when required.
- Ensure compliance with USAID regulations, Integrity's policies and standard operating procedures, and national laws and policies.
- Promote activity sustainability through networking, linkages to other activities, capacity

building of activity staff, and institutional strengthening in support of localization.
