

Peacebuilding Evaluation, Analysis, Research, and Learning (PEARL) USAID / Bureau for Conflict Prevention and Stabilization (CPS) / Center for Conflict and Violence Prevention (CVP) 2022 – 2025


We implemented a large language model and used generative AI to produce tailored information summaries from 40,000 documents.



TPM of the Afghanistan Reconstruction Trust Fund (ARTF), Phase III, World Bank 2020 – 2024

Integrity, with partners, provided the Third-Party Monitoring (TPM) services to the 18-year, \$12.3-billion multi-donor ARTF.

We implemented a digital platform and mobile app for a multi-year, nationwide TPM agent. We automated data analysis and quantitative reporting for the World Bank in Afghanistan.





Global Monitoring, Evaluation and Learning (GMEL) Partnership, FCDO 2019 – 2024

Integrity led the GMEL Partnership for the UK's cross-government UK Integrated Security Fund (UKISF), which has over 90 programmes in more than 80 countries and territories.

We employed cutting-edge data science techniques to support UKISF decision making through a suite of machine learning, natural language processing and predictive modelling products.



C. Energy imports and exports


Findings and observations:

- **The WB region is import dependent.** Energy imports accounted for 35% of total energy use across the region in 2018 [2, pg. 483].
- **North Macedonia had the highest import dependency in 2018 in terms of the contributions of imports to overall consumption** however Serbia and BiH import the most energy [2, pg. 483].
- **Serbia imports significantly more energy than all other WB countries** (approx. 300,000 TJ), with the majority of imports consisting of natural gas and crude oil, NGL (natural gas liquids) and refinery feedstocks.
- **BiH imports the most coal** and is also a significant coal exporter.
- **Albania is a significant exporter** of crude oil, NGL, refinery feedstocks. In 2020 this was the fourth most exported product from Albania [22].

Figure 7 – Energy import (+) and export (-) trends by source




