

WEST AND NORTH AFRICA | 2019 - PRESENT

Integrity is the monitoring, evaluation, research and learning provider for DFID's Safety Support and Solutions Phase II (SSSII) programme, which seeks to protect vulnerable migrant populations along the Central Mediterranean Migration Route (see map) from harm. In response to COVID-19, as risks rise and assistance needs change, we have adapted our independent monitoring support to continue to track programming while ensuring beneficiary safety and well-being. As part of this project, we are also undertaking a series of research studies that will directly engage migrants and refugees. **Read more here**



COVID-19 will affect Pakistan's ability to Build Disaster Resilience

PAKISTAN | 2019 - PRESENT

Integrity is providing third-party monitoring services to DFID's Building Disaster Resilience in Pakistan (BDRP) programme, with the objective of increasing accountability, oversight, and evidence-based learning. Our third-party monitoring activities are conducted in all nine implementation districts across Punjab, Sindh, and Khyber Pakhtunkhwa. After the outbreak and spread of COVID-19, we have broadened the existing data monitoring and visualisation work to include the spread and impact of the virus amongst BDRP target communities, including looking at the readiness of some health facilities to respond, by province. Analysing the political economy in the DRC during COVID-19: how we adapt our approach to continue informing citizen groups in the DRC

DRC | 2019 - PRESENT

Integrity currently supports a programme for Engaging Subnational Authorities in Accountable Practices (ESAAP – implemented by IRC and funded by DFID) through rigorous analysis of the political economy in three provinces in the DRC. Our analysis supports citizen groups by identifying opportunities for systematic change that respond to community needs. Citizen groups, called community action groups, use our analysis to develop issues-based initiatives centred around locally informed solutions. In response to the COVID-19 crisis, we have adapted our approach to Political Economy Analysis (PEA), to allow the consultations to happen remotely. **Read more here**

After the spread of COVID-19 to Pakistan, we have adapted our monitoring, validation and research work for DAFPAK and introduced new ways to assess the impact of COVID-19 on family planning services.
